RULES AND REGULATIONS

- 1) All food vendors must have food handlers permit
- 2) All food vendors must have a 10 pound fire extinguisher (fully charged)
- 3) **NO** alcohol is allowed in park
- 4) Vendor must present parking decal and entry armband/pass to enter
- 5) Vendor must load in between 6am and 9am
- 6) All vendors subjected to search before entering the park
- 7) Vendors' vehicle must be out of event area and properly parked by 9am
- 8) All fires must be properly extinguished before you leave the park
- 9) Vendors must load out of park immediately after event is over
- 10) Vendor must clean up their immediate space before leaving park

VENDOR AUTHORIZATION & INDEMNIFICATION
